I have done the "taxes" for the non-profit, which now is a Form 990. Fortunately, we can use the -EZ version! We did have to fill out part of Schedule A, however. It is all in the attached scanned file. Please review and sign the Form 990 on page 4. Schedule A doesn't require a signature. I am hoping to get this out and posted tomorrow or Tue.

I worked without the account statements to sanity check: The only account activity should have been +\$250 from Paypal (the two individual's donations). I can't think of anything else, as there only was legal expenses (and a lot of that!) but Sine Nomine donated the legal expenses, thus they don't show up on the Foundation's books.

Could you also please compare whether my presumed numbers:
Cash in hand at PNC: \$10,840

Currently \$10,590.71

Paypal has \$242.82 (\$251 in donations minus fees). I have executed a transfer back to the PNC account now. New total is \$10833.53.

Escrow with T+B: \$2,650

Assuming that's the same as before there should be no change.

Has there been any progress on the Pennsylvania tax forms? We also need to submit the documentation for the board changes. I'm actually on vacation right now so I can research the forms some more after I get back if needed.

I can sign the document with the updated numbers whenever I get it. I don't have a scanner here so I can't change the numbers, but I can sign it.
